

2017 Westoba First Days Back Contest

Official Contest Rules and Regulations

Westoba Credit Union's (The Sponsor) "First Days Back" (The Contest) will be conducted in Manitoba only. No purchase necessary. Participants must be attending post-secondary school in Manitoba and of the age of majority in the province of Manitoba or older at the time of entry. Void in whole or part where prohibited by law. Entry in this Contest constitutes acceptance of these contest rules (The Rules).

1. CONTEST PERIOD:

The contest begins at 12:00:00 a.m. Central Time ("CT") on Tuesday, September 5, 2017 and ends at 11:59:59 p.m. CT on Friday, September 15, 2017. ("Contest End Date") with the "Grand Prize" draw at 10:00:00 a.m. CT on Monday, September 18th, 2017.

2. ELIGIBILITY:

The Contest is open to all legal residents of Manitoba who are the age of majority in the Province of Manitoba or older at the time of entry into the contest, and attending a post-secondary school in Manitoba. Employees of, or representatives of, Westoba Credit Union (the "Sponsor") or its subsidiaries or affiliates, or of their advertising and promotion agencies or their subsidiaries and affiliates, are not eligible to win.

3. HOW TO PARTICIPATE:

Post your "First Days Back" photo publically to Facebook. Then tag Westoba Credit Union (the "Sponsor") by mentioning them in your photo entry.

Each entry will be pooled into a list of entries. During the duration of the contest from Monday to Friday a random draws will take place before the "Grad Prize" draw at 10:00:00 a.m. CT on Monday, September 18th, 2017. The selected winners from the pool of participants will be placed back into the Grand Prize draw. All entries become the property of the Sponsor and will not be returned or acknowledged.

4. PRIZE:

There will be five (5) \$50.00 Heritage Co-op Gift Cards, and the "Grand Prize" of a HP Chromebook 11 G5. Winners will be chosen through a random draw through out the contest period and at 10:00:00 a.m. CT on Monday, September 18th, 2017 for the "Grand Prize".

5. DRAW DATE:

Five (5) random draws will take place until the contest close date at Westoba Credit Union Corporate Office in Brandon, MB. Five (5) eligible entrants will be randomly drawn from among the eligible entries. The odds of being selected depend on the number of eligible entries received. Unsuccessful entries will be carried over each day. On the day of the "Grand Prize" draw all names will go back in for the chance to win the HP Chromebook.

6. PRIZE AWARDING:

If you are selected as a potential winner, you will be provided with specific instructions on what you are required to do in order to claim your Prize via Facebook. The Prize will be awarded only upon verification and final approval by Westoba Credit Union “the Sponsor”. The Prize must be held on deposit at Westoba Credit Union for a minimum of twelve (12) months or the Prize will be forfeited.

Attempts will be made to contact the selected Entrants through Facebook for a period of three (3) business days following the Draw Date. If the selected Entrant cannot be contacted within the allotted time, the Sponsor reserves the right to void that entry and select another eligible Entrant for the Prize.

In order to be declared an official winner, the selected Entrant must correctly answer a skill-testing mathematical question without mechanical or other assistance. The selected Entrant will be required to complete, sign and return a *Declaration and Release Form* within forty eight (48) hours of receipt. If the selected Entrant fails to complete, sign and return the *Declaration and Release Form* within forty eight (48) hours and/or provides an incorrect answer to the skill-testing mathematical question, the Sponsor reserves the right to void that Entry and select another eligible Entrant for the Prize.

By completing, signing and returning the *Declaration and Release Form*, the Entrant:

Further, the Sponsor reserves the right, in their sole discretion, to terminate the Contest, in whole or in part, or modify, amend or suspend the Contest and/or the Contest Rules in any way at any time for any reason without prior notice or compensation.
